Part 1

General & Interpretation

1. General

The regulations contained in Table A in the First Schedule to the predecessor Companies Ordinance (Cap. 32 of the Laws of Hong Kong) and in Schedule 2 to the Companies (Model Articles) Notice (Cap. 622H) and any similar regulations in any other legislation relating to companies do not apply to the Company.⁴

2. Interpretation

1. Interpretation

(1) ~~(1)~~ In these articles—

alternate (候補者) and *alternate director* (候補董事) mean a person appointed by a director as an alternate under article 28(1);

appointor (委任者)—see article 28(1);

articles (本《章程細則》) means the articles of association of the company;

associated company (有聯繫公司) means—

- (a) ~~(a)~~ a subsidiary of the company;
- (b) ~~(b)~~ a holding company of the company; or
- (c) ~~(c)~~ a subsidiary of such a holding company;

clear days means, in relation to a period of notice, that period excluding the day on which the notice is served or deemed to be served and the day for which it is given or on which it is to take effect;

distribution recipient (分派對象) means, in relation to a share in respect of which a dividend or other sum is payable—

- (a) ~~(a)~~ the holder of the share;
- (b) ~~(b)~~ if the share has 2 or more joint holders, whichever of them is named first in the register of members; or
- (c) ~~(c)~~ if the holder is no longer entitled to the share by reason of death or bankruptcy or otherwise by operation of law, the transmittee;

fully paid (已繳足款), in relation to a share, means the price at which the share was issued has been fully paid to the company;

⁴ Guidance Note: This article makes it clear that this set of articles are the Company's constitution and there is no need to refer to any other documents or regulations. The provisions of the Ordinance and other applicable legislation will still apply to the Company but otherwise, the articles are intended to be self-contained with respect as to how the Company is owned and managed.

holder (持有人), in relation to a share, means the person whose name is entered in the register of members as the holder of the share;

mental incapacity (精神上無行為能力) has the meaning given by section 2(1) of the Mental Health Ordinance (Cap. 136);

mentally incapacitated person (精神上無行為能力者) means a person who is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs;

Ordinance (《條例》) means the Companies Ordinance (Cap. 622);

paid (已繳) means paid or credited as paid;

proxy notice (代表通知書)—see article 49(1);

register of members (成員登記冊) means the register of members of the company;

transmittee (承傳人) means a person entitled to a share by reason of the death or bankruptcy of a member or otherwise by operation of law.

- (2) ~~(2)~~ Other words or expressions used in these articles have the same meaning as in the Ordinance as in force on the date these articles become binding on the company.
- (3) ~~(3)~~ For the purposes of these articles, a document is authenticated if it is authenticated in any way in which section 828(5) or 829(3) of the Ordinance provides for documents or information to be authenticated for the purposes of the Ordinance.

Part 21A

Objects, Purpose and Powers⁵

1A. Objects, Purpose and Powers

- (1) In accordance with Section 116(1) of the Ordinance, the objects of the Company are restricted to those set out in the following provisions of this Article.
- (2) The Company is established for the following objects:
- (a) [Insert list of the Company's objects]

⁵ Guidance Note: A company's objects are unrestricted unless the company's articles provide otherwise. Where a company's constitution does state the objects of the company, the members have power to restrain the controllers of the company from exercising their powers for a purpose that is outside the stated objects. In drafting an objects clause, it may be useful to first consider the underlying social objectives of the Company. For example, improving the employability of deprived groups, fair-trading, raising public awareness on certain issues such as elder care, etc.

- (3) In furtherance of the principal objects but not otherwise and subject to Part 1B (Asset Lock), the Company has the power:

 - (a) [Insert detailed list of the Company's powers];
 - (b) [to raise funds and other contributions in the form of donations, annual subscriptions, or otherwise, by personal or written appeals, public meetings or otherwise, as are expedient;]
 - (c) [to print and publish any newspapers, periodicals, books or leaflets;]
 - (d) [to enter into, make, perform and carry out any arrangements or contracts with any person, company, body corporate, association, organization, institution, or government authority for attainment and furtherance of the objects of the Company, to obtain from any such person, company, body corporate, association, organization, institution, or government authority any rights, licences, franchises, permits, privileges and concessions which the Company thinks desirable;]
 - (e) [to cooperate with and assist bodies, corporations, unincorporated associations, organizations and institutions with objects similar to the objects of the Company, cooperate with government, national and international organizations, institutions which are in any way related or concerned with objects of the Company;]
 - (f) [to accept any gift of property, whether subject to any special trust or not, for any purpose within the objects;]
 - (g) [to receive money on deposit or loan, and to borrow or raise money in such manner as the Company thinks fit, and to secure the repayment of any money borrowed, raised or owing by mortgage, charge or lien upon all or any of the property or assets of the Company;]
 - (h) [to invest and deal with any money of the Company not immediately required for any of its objects in and upon such investments, securities, deposits or property, and to vary or realize the same at any time and in a proper and prudent manner, as is from time to time determined by the Company;]
 - (i) [to apply money for any of the objects hereof;]
 - (j) [to draw, make, accept, endorse, discount, execute and issue promissory notes, checks, bills of exchange, debentures and other negotiable or transferable instruments;]
 - (k) [to employ, hire, remunerate, provide benefits to, to dismiss and replace with other persons from time to time as the Company thinks fit, employees and staff to carry out the administration and objects of the

Company, and lawyers, accountants, surveyors or other professional or non-professional advisors or consultants as are considered expedient;]

- (l) [to purchase, take on lease, hire or otherwise acquire, own, hold, use and occupy in Hong Kong or elsewhere any land or other real or personal property, or any right or interest therein, which the Company thinks necessary or convenient for the purposes or attainment and furtherance of its objects, and to work, improve, maintain, develop and turn to account, sell, let, surrender, mortgage, charge, dispose of, or other deal with the same or any other property of the Company;]
- (m) [to purchase, take on lease or in exchange, hire or otherwise acquire in any way any property such as equipment, plant, machinery, furniture, fixture, fittings, chattels and goods of any nature or description necessary or convenient to enable the Company to fulfil its objects, and to sell, dispose of, or otherwise deal with the same;]
- (n) [to commence, maintain, or as the case may require, oppose any proceedings, suits, actions or applications which are necessary to directly or indirectly benefit or protect the Company;] and
- (o) [to do all such other lawful things as are incidental or conducive to the pursuit or to the attainment of any of the objects.]

Part 1B

Asset Lock⁶

1B. General Asset Lock

The Company shall not transfer any of its assets other than for full consideration, unless the assets are transferred to institutions, social enterprises or registered charitable institutions having objects similar to the objects of the Company, or otherwise for the benefit of the community.⁷

1C. Asset Lock on Winding Up

- (1) If the company is wound up and a surplus remains after the payment of debts proved in the winding up, the liquidator—

 - (a) may, with the required sanction and subject to the cap on distribution to a member as set out in paragraph (1)(b) below, divide amongst the members in specie or kind the whole or any part of the assets of the company (whether they consist of property of the same kind or not)

⁶ Guidance Note: Social enterprises that are not granted tax exemption may, on a voluntary basis, adopt “asset lock” and “cap of profit sharing” provisions. To qualify for tax exemption, social enterprises will need to fulfil a number of requirements. In practice, the assets of social enterprises granted tax exemption must be locked and profit sharing among its members is prohibited.

⁷ Guidance Note: If you have a specific social enterprise in mind, it is also possible to identify the social enterprise(s) here.

and may, for this purpose, set a value the liquidator thinks fair on any property to be so divided;

(b) may determine how the division is to be carried out between the members or different classes of members, provided that with respect to a member, any distribution under this article shall not exceed the paid-up capital of such member; and

(c) shall give or transfer the residual assets after the process in paragraph (1)(b), if any, to institutions or registered charitable institutions having objects similar to the objects of the Company, or otherwise for the benefit of the community, to the extent permitted under Hong Kong law.

(2) With respect to paragraph 1(b), the liquidator may, with the required sanction, vest the whole or part of those assets in trustees on trust for the benefit of the contributories that the liquidator, with the required sanction, thinks fit, but a member must not be compelled to accept any shares or other securities on which there is any liability.

(3) With respect to paragraph 1(c), the liquidator may, with the required sanction, choose recipient(s) that the liquidator, with the required sanction, thinks fit, but such recipient(s) must not be compelled to accept any shares or other securities on which there is any liability.

(4) In this article—

required sanction (規定認許) means the sanction of a special resolution of the company and any other sanction required by the Ordinance.

Part 2

(1) ~~(1)~~ The company is a private company and accordingly—

(a) ~~(a)~~ a member's right to transfer shares is restricted in the manner specified in this article;

(b) ~~(b)~~ the number of members is limited to 50; and

(c) ~~(c)~~ any invitation to the public to subscribe for any shares or debentures of the company is prohibited.

(2) ~~(2)~~ The directors may in their discretion refuse to register the transfer of a share.

(3) ~~(3)~~ In paragraph (1)(b)—

member (成員) excludes—

(a) ~~(a)~~ a member who is an employee of the company; and

- (b) ~~(b)~~ a person who was a member while being an employee of the company and who continues to be a member after ceasing to be such an employee.
- (4) ~~(4)~~ For the purposes of this article, 2 or more persons who hold shares in the company jointly are to be regarded as 1 member.

Directors and Company Secretary

Division 1—Directors' Powers and Responsibilities

4. ~~3.~~ Directors' general authority

- (1) ~~(1)~~ Subject to the Ordinance and these articles, the business and affairs of the company are managed by the directors, who may exercise all the powers of the company.
- (2) ~~(2)~~ An alteration of these articles does not invalidate any prior act of the directors that would have been valid if the alteration had not been made.
- (3) ~~(3)~~ The powers given by this article are not limited by any other power given to the directors by these articles.
- (4) ~~(4)~~ A directors' meeting at which a quorum is present may exercise all powers exercisable by the directors.

5. ~~4.~~ Members' reserve power

- (1) ~~(1)~~ The members may, by special resolution, direct the directors to take, or refrain from taking, specified action.
- (2) ~~(2)~~ The special resolution does not invalidate anything that the directors have done before the passing of the resolution.

6. ~~5.~~ Directors may delegate

- (1) ~~(1)~~ Subject to these articles, the directors may, if they think fit, delegate any of the powers that are conferred on them under these articles—
- (a) ~~(a)~~ to any person or committee⁸;
- (b) ~~(b)~~ by any means (including by power of attorney);
- (c) ~~(c)~~ to any extent and without territorial limit;
- (d) ~~(d)~~ in relation to any matter; and
- (e) ~~(e)~~ on any terms and conditions.

⁸ Guidance Note: In practice, the board may consider establishing a special committee to periodically evaluate the social and/or environmental performance of the Company. However, the delegation does not absolve directors of their general duties towards the Company and their overall responsibility for its management.

(2) [[Option A: The directors shall prepare and review, from time to time, a list of matters that should be reserved to the directors and which may not be delegated (“Non-Delegable Board Matters”).]

[Option B: The following functions are reserved to the directors and may not be delegated (“Non-Delegable Board Matters”): [identify matters which should be reserved to the board].]⁹

~~(2)~~ If the directors so specify, the delegation may authorize further delegation of the directors’

(3) powers by any person to whom they are delegated.

(4) ~~(3)~~The directors may—

(a) ~~(a)~~ revoke the delegation wholly or in part; or

(b) ~~(b)~~ revoke or alter its terms and conditions.

7. ~~6.~~ **Committees**

(1) [Without prejudice to the freedom of the directors to establish any other committees, there shall be established [an audit committee], [a nominations committee], [a remuneration committee], [a corporate governance committee] and [insert any other committees, as appropriate]].

~~(1)~~ The directors may make rules providing for the conduct of business of the committees to

(2) which they have delegated any of their powers.

(3) ~~(2)~~ The committees must comply with the rules.

7A. Consideration of different stakeholders and the community

(1) Consistent with the Company’s objects and purposes described in Article 1A, in discharging their duties, the directors shall, when exercising the powers of the Company, consider the following factors:

(a) the ability of the Company to accomplish its objects and purposes by way of such exercise;

(b) the impact of such exercise on the members of the Company;

(c) the impact of such exercise on the employees and workforce of the Company and its subsidiaries and suppliers;

(d) the interests of customers as beneficiaries of the general and specific purposes of the Company;

(e) community and societal considerations, including those of any community in which offices or facilities of the Company or its subsidiaries or suppliers are located;

⁹ Guidance Note: A social enterprise may wish to formalize the functions reserved to the board of directors. However, this may not be suitable for all companies. Option A is more appropriate than Option B if flexibility is required and/or if a social enterprise would like to avoid having to amend the articles (which require a special resolution of the shareholders) whenever there is a change to the list.

- (f) the impact of such exercise on the local and global environment; and
 - (g) the short-term and long-term interests of the Company, including benefits that may accrue to the Company from its long-term plans and the possibilities that these interests may be best vested by the continued independence of the Company.
- (2) Directors may also consider the resources, intent, and conduct (past, stated and potential) of any person seeking to acquire control of the Company, and any other pertinent factors or the interests of any other group that they deem appropriate, consistent with the Company’s objects and purposes described in Article 1A.

7B. Annual Purpose and Progress Review

- (1) The directors shall conduct an internal review and assessment of its overall performance and progress in relation to its objects and purposes as described in Article 1A on an annual basis (the “**Annual Purpose and Progress Review**”).
- (2) The Annual Purpose and Progress Review may be drawn up by the directors based on an impact measurement matrix established by the directors which will take into account various factors, including, without limitation, the impact of the Company’s actions on the stakeholders set out in Article 7A(1).
- (3) [The impact measurement matrix to be established by the directors shall include, without limitation, the following categories:
- (a) [governance];
 - (b) [workers and employees];
 - (c) [community];
 - (d) [environment]; and
 - (e) [*insert other relevant categories*].¹⁰
- (4) [Each of [the audit committee], [the remuneration committee], [the nomination committee], [the corporate governance committee] and [*insert any other committees, as appropriate*] shall prepare a written report (each, a “**Committee Report**”), to be appended to the Annual Purpose and Progress Review. The Committee Report shall include:
- (a) a summary of the relevant committee’s performance with respect to the Company’s impact measurement matrix and the committee’s progress in relation to its objects, goals and terms of reference; and
 - (b) a summary of the relevant committee’s goals, plans and areas for improvement in the next twelve (12) months.

¹⁰ Guidance Note: This is based on the main categories set out in the B-Corp impact assessment: <http://bimpactassessment.net/how-it-works/assess-your-impact>. A social enterprise can use this as a starting point and tailor its impact measurement matrix accordingly.

- (6) [\[The Company shall post a copy of the Annual Purpose and Progress Review to the public portion of its website, if any, within sixty \(60\) days of the annual general meeting except that \[the compensation paid to directors, any financial or proprietary information and \[list other sensitive/confidential materials, if any\] included in the Annual Purpose and Progress Review may be omitted from the Annual Purpose and Progress Review as publicly posted.\]¹¹](#)

Division 2—Decision-taking by Directors

8. ~~7.~~ **Directors to take decision collectively**

- (1) ~~(1)~~ A decision of the directors may only be taken—
- (a) ~~(a)~~ by a majority of the directors at a meeting; or

¹⁵ Guidance Note: A social enterprise may want to include additional restrictions on the transfer of shares or qualifications on its shareholders' rights to transfer their shares, where, for example, a transfer of shares by a particular shareholder could have an impact on the management or control of the social enterprise. There is flexibility in the type and extent of restrictions that may be applied to the transfer of shares in social enterprises that are private companies limited by shares. It is possible to set out more detailed consent provisions such as a pre-emption procedure. A pre-emption right on transfer involves a prohibition on the transfer of shares unless the shareholder wishing to make the transfer first offers the shares for sale (often at a specified price) to the existing shareholders, or to certain other persons.

- (6) ~~(6)~~ All the limitations, restrictions and other provisions of these articles relating to the right to transfer and the registration of transfer of shares apply to the notice under paragraph (1) or the transfer under paragraph (5), as if the transmission had not occurred and the transfer were a transfer made by the holder of the share before the transmission.

70. ~~68.~~ Transmittees bound by prior notices

If a notice is given to a member in respect of shares and a transmittee is entitled to those shares, the transmittee is bound by the notice if it was given to the member before the transmittee's name has been entered in the register of members.

**Division 5—Alteration and Reduction of Share Capital, Share Buy-backs ~~and~~
and Allotment of Shares**

71. ~~69.~~ Alteration of share capital

The company may by ordinary resolution alter its share capital in any one or more of the ways set out in section 170(2)(a), (b), (c), (d), (e) and (f)(i) of the Ordinance, and section 170(3), (4), (5), (6), (7) and (8) of the Ordinance applies accordingly.

72. ~~70.~~ Reduction of share capital

The company may by special resolution reduce its share capital in accordance with Division 3 of Part 5 of the Ordinance.

73. ~~71.~~ Share buy-backs

The company may buy back its own shares (including any redeemable shares) in accordance with Division 4 of Part 5 of the Ordinance.

74. ~~72.~~ Allotment of shares

The directors must not exercise any power conferred on them to allot shares in the company without the prior approval of the company by resolution if the approval is required by section 140 of the Ordinance.

Division 6—Distributions

75. ~~73.~~ Procedure for declaring dividends

Subject to the Asset Lock Provisions in Part 1B and Article 76 below:

- (1) ~~(1)~~ The company may at a general meeting declare dividends, but a dividend must not exceed the amount recommended by the directors.
- (2) ~~(2)~~ The directors may from time to time pay the members interim dividends that appear to the directors to be justified by the profits of the company.
- (3) ~~(3)~~ A dividend may only be paid out of the profits in accordance with Part 6 of the Ordinance.
- (4) ~~(4)~~ Unless the members' resolution to declare or directors' decision to pay a dividend, or the terms on which shares are issued, specify otherwise, it must be paid by reference to each member's holding of shares on the date of the resolution or decision to declare or pay it.
- (5) ~~(5)~~ Before recommending any dividend, the directors may set aside out of the profits of the company any sums they think fit as reserves.

- (6) ~~(6)~~ The directors may—
- (a) ~~(a)~~ apply the reserves for any purpose to which the profits of the company may be properly applied; and
 - (b) ~~(b)~~ pending such an application, employ the reserves in the business of the company or invest them in any investments (other than shares of the company) that they think fit.
- (7) ~~(7)~~ The directors may also without placing the sums to reserve carry forward any profits that they think prudent not to divide.

76. **Dividend cap**

The income and property (including assets) of the Company shall be applied towards the promotion of the objects of the Company set forth in Article 1A. Dividends payable to the members per financial year is capped at the maximum of [●]% of net profit after tax of the Company subject to a maximum return to its members of not more than [●]% on their paid up capital per financial year.¹⁶

78. **75. No interest on distributions**

The company may not pay interest on any dividend or other sum payable in respect of a share unless otherwise provided by—

76. Unclaimed distributions

(1) ~~(1)~~ If dividends or other sums are payable in respect of shares and they are not claimed after having been declared or become payable, they may be invested or made use of by the directors for the benefit of the company until claimed.

(2) ~~(2)~~ The payment of the dividends or other sums into a separate account does not make the company a trustee in respect of it.

(3) ~~(3)~~ A distribution recipient is no longer entitled to a dividend or other sum and it ceases to remain owing by the company, if—

(a) ~~(a)~~ 12 years have passed from the date on which the dividend or other sum became due for payment; and

(b) ~~(b)~~ the distribution recipient has not claimed it.

77. Non-cash distributions

(1) ~~(1)~~ Subject to the terms of issue of the share in question, the company may, by ordinary resolution on the recommendation of the directors, decide to pay all or part of a dividend or other distribution payable in respect of a share by transferring non-cash assets of equivalent value (including, without limitation, shares or other securities in any company).

(2) ~~(2)~~ For paying a non-cash distribution, the directors may make whatever arrangements they think fit, including, if any difficulty arises regarding the distribution—

(a) ~~(a)~~ fixing the value of any assets;

(b) ~~(b)~~ paying cash to any distribution recipient on the basis of that value in order to adjust the rights of recipients; and

(c) ~~(c)~~ vesting any assets in trustees.

78. Waiver of distributions

(1) ~~(1)~~ Distribution recipients may waive their entitlement to a dividend or other distribution payable in respect of a share by executing to the company a deed to that effect.

- (2) ~~(2)~~ But if the share has more than one holder or more than one person is entitled to the share (whether by reason of the death or bankruptcy of one or more joint holders, or otherwise), the deed is not effective unless it is expressed to be executed by all the holders or other persons entitled to the share.

Division 7—Capitalization of Profits

79. Capitalization of profits

- (1) ~~(1)~~ The company may by ordinary resolution on the recommendation of the directors capitalize profits.
- (2) ~~(2)~~ If the capitalization is to be accompanied by the issue of shares or debentures, the directors may apply the sum capitalized in the proportions in which the members would be entitled if the sum was distributed by way of dividend.
- (3) ~~(3)~~ To the extent necessary to adjust the rights of the members among themselves if shares or debentures become issuable in fractions, the directors may make any arrangements they think fit, including the issuing of fractional certificates or the making of cash payments or adopting a rounding policy.

Miscellaneous Provisions

Division 1—Communications to and by Company

83.

80. Means of communication to be used

- (1) ~~(1)~~ Subject to these articles, anything sent or supplied by or to the company under these articles may be sent or supplied in any way in which Part 18 of the Ordinance provides for documents or information to be sent or supplied by or to the company for the purposes of the Ordinance.
- (2) ~~(2)~~ Subject to these articles, any notice or document to be sent or supplied to a director in connection with the taking of decisions by directors may also be sent or supplied by the means by which that director has asked to be sent or supplied with such a notice or document for the time being.
- (3) ~~(3)~~ A director may agree with the company that notices or documents sent to that director in a particular way are to be deemed to have been received within a specified time of their being sent, and for the specified time to be less than 48 hours.

Division 2—Administrative Arrangements

84.

81. Company seals

- (1) ~~(1)~~ A common seal may only be used by the authority of the directors.
- (2) ~~(2)~~ A common seal must be a metallic seal having the company's name engraved on it in legible form.

- (3) ~~(3)~~ Subject to paragraph (2), the directors may decide by what means and in what form a common seal or official seal (whether for use outside Hong Kong or for sealing securities) is to be used.
- (4) ~~(4)~~ Unless otherwise decided by the directors, if the company has a common seal and it is affixed to a document, the document must also be signed by at least 1 director of the company and 1 authorized person.
- (5) ~~(5)~~ For the purposes of this article, an authorized person is—
- (a) ~~(a)~~ any director of the company;
 - (b) ~~(b)~~ the company secretary; or
 - (c) ~~(c)~~ any person authorized by the directors for signing documents to which the common seal is applied.
- (6) ~~(6)~~ If the company has an official seal for use outside Hong Kong, it may only be affixed to a document if its use on the document, or documents of a class to which it belongs, has been authorized by a decision of the directors.
- (7) ~~(7)~~ If the company has an official seal for sealing securities, it may only be affixed to securities by the company secretary or a person authorized to apply it to securities by the company secretary.

85. ~~82.~~ No right to inspect accounts and other records

A person is not entitled to inspect any of the company's accounting or other records or documents merely because of being a member, unless the person is authorized to do so by—

- (a) ~~(a)~~ an enactment;
- (b) ~~(b)~~ an order under section 740 of the Ordinance;
- (c) ~~(c)~~ the directors; or
- (d) ~~(d)~~ an ordinary resolution of the company.

86. ~~83.~~ Auditor's insurance

- (1) ~~(1)~~ The directors may decide to purchase and maintain insurance, at the expense of the company, for an auditor of the company, or an auditor of an associated company of the company, against—
- (a) ~~(a)~~ any liability to any person attaching to the auditor in connection with any negligence, default, breach of duty or breach of trust (except for fraud) occurring in the course of performance of the duties of auditor in relation to the company or associated company (as the case may be); or
 - (b) ~~(b)~~ any liability incurred by the auditor in defending any proceedings (whether civil or criminal) taken against the auditor for any negligence, default, breach of duty or breach of trust (including fraud) occurring in the course of performance of the duties of auditor in relation to the company or associated company (as the case may be).

- (2) ~~(2)~~ In this article, a reference to performance of the duties of auditor includes the performance of the duties specified in section 415(6)(a) and (b) of the Ordinance.

84. Winding-up

~~(1) If the company is wound up and a surplus remains after the payment of debts proved in the winding up, the liquidator—~~

~~(a) may, with the required sanction, divide amongst the members in specie or kind the whole or any part of the assets of the company (whether they consist of property of the same kind or not) and may, for this purpose, set a value the liquidator thinks fair on any property to be so divided; and~~

~~(b) may determine how the division is to be carried out between the members or different classes of members.~~

~~(2) The liquidator may, with the required sanction, vest the whole or part of those assets in trustees on trust for the benefit of the contributories that the liquidator, with the required sanction, thinks fit, but a member must not be compelled to accept any shares or other securities on which there is any liability.~~

~~(3) In this article—~~

~~*required sanction* (規定認許) means the sanction of a special resolution of the company and any other sanction required by the Ordinance.~~
